IMPORTANT INFORMATION ABOUT PROCEDURES FOR OPENING A NEW ACCOUNT
 Federal law requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. What this means to you: When you open an account, Bank One will ask for two types of identification in addition to your name, residential address, date of birth and Social Security number, which allows Bank One to verify your identity.

CERTIFICATION – I certify under penalty of perjury that:
 (1) the Taxpayer Identification Number given is correct, and

 (b) I have not been notified by the Internal Revenue Service (IRS) that I am subject to backup withholding as a result of failure to report all interest or dividends, or
