RE: Summer course withdrawal and refund policy

Thank you for registering for the 2017 Summer Session! Listed on the back of this letter is a withdrawal and refund schedule for summer courses, by session. The beginning and ending dates of your course(s) will correspond with one of the sessions' dates. If your course is one of the few exceptions to the session dates or an individualized study, please contact me directly for withdrawal and refund information, if you plan to drop the class after it begins.

<u>Dropping Classes:</u> You must <u>officially</u> drop or withdraw from a course by filling out a form at the Records Office or, if you are not on campus, by emailing the Records Office at records@marietta.edu. If you drop the course after it begins, please email the instructor also. **Do not assume that you are automatically dropped from the course if you never start it or do not pay for it!** You will not be deregistered based on non-payment or lack of participation. Also, be aware that the instructor cannot withdraw you from a course, even if you notify him/her that you are dropping the course.

Because summer courses are so condensed, it is **vital** that you pay attention to the withdrawal and refund deadlines. For some courses, one <u>day</u> equates to one <u>week</u> during the regular semester. Therefore, you may have only one or two days to drop the course without a "W" grade or to get a large percentage of your tuition refund. **Please note that full refunds are given only if the course is dropped before the second day of the course.** Once the course begins, refunds will be prorated according to the schedule on the back of this letter.

## **Payment Terms:**
