

Residency Requirement Application Policy Statement

Marietta College seeks to provide an environment in which a sense of community is an integral part of the education it offers. As a private, residential, undergraduate College, it requires all students to reside in College-owned or College-related housing for eight semesters, unless the student(s) meet one of the following exceptions:

- Has resided in a college residence hall for at least eight (8) semesters prior to making the request.
- Has reached the age of twenty-three prior to the term(s) for which the request is made.
- Is married.
- Is living with a parent/guardian (resident of Ohio or West Virginia) within a sixty-mile radius of Marietta College.*
- Is enrolled in eleven (11) hours or less credit hours.
- Has received permission from the Dean of Students for special circumstances.

All students residing on campus must participate in one of the College's meal plans. Students, who reserve rooms in College housing, contract for the entire year. No one is permitted to move within, to, or from College housing except in special cases approved by the Director of Residence Life.

Students may request permission to live off-campus by filing a Residential Requirement Waiver Application with the Director of Residence Life. Students will be billed for room and board as residential students if this approved application is not on file in the Office of Student Life.

All residence halls are closed during all College vacation periods. When halls have been closed during a College vacation, they re-open at 9:00 a.m., one day preceding the resumption of classes. However, dining services resume the first day of classes. All residence halls close at 9:00 p.m. for graduates the evening of Commencement.

Waiver applications must be received by the Office of Student Life 30 days prior to the first day of classes in the semester you are applying to live off campus.

*Resident shall mean any person who maintains a 12-month place or places of residence within the 60-mile limit of Marietta College, who is qualified as a resident to vote in Ohio or West Virginia and receive state public assistance, and who may be subjected to tax liability. Person can not declare himself or herself to be a resident of any other state or nation.

Additional criteria for residency with a parent or guardian:

1. Parent/guardian must be subject to tax liability in Ohio or West Virginia.
2. Parent/guardian must qualify to vote in Ohio or West Virginia.
3. Parent/guardian is eligible to receive Ohio or West Virginia public assistance.
4. Parent/guardian has an Ohio or West Virginia driver's license and or Motor Vehicle Registration.
