## **Application**

International Students must complete the CPT form, in addition to the Internship Form for Marietta College, if an internship is in the U.S., is required as a graduation requirement, or if you have an active internship/job offer.

As an F-1 student, you may engage in CPT if you meet the following requirements:

- 1. You have been lawfully enrolled in school full-time for at least nine consecutive months.
- 2. Your proposed employment is **related to your major** field of study.
- 3. Your academic program requires employment OR you will earn college credit from your employment

 YOU CAN ONLY INTERN IN THE U.S. FOR COMPANIES RELATED TO YOUR CURRENT MAJOR OR MINOR. For example: you study Media at MC but have a degree in Accounting in your home country. You can only have an internship within Media IF your internship is in the U.S.

**NOTE:** IF THE INTERNSHIP IS WITHIN THE U.S. AND NOT REQUIRED FOR YOUR MAJOR, THEN YOU ARE REQUIRED TO REGISTER FOR A MINIMUM OF ONE CREDIT HOUR IN THE SUMMER, FALL OR SPRING SESSION (the same session as the internship) IN ORDER TO COMPLY WITH U.S. IMMIGRATION. If this internship is paid, or you receive compensation like housing, travel expenses etc. then you must have it added to your I-20 as CPT. You will need to CHANGE your I-20—and complete a I-20 Change Request Form in the OEA office.

\*IF THIS IS A PAID INTERNSHIP, YOU ARE REQUIRED TO APPLY FOR A SOCIAL SECURITY CARD. BRING YOUR LETTER OF EMPLOYMENT OFFERING TO THE OFFICE OF EDUCATION ABROAD in Thomas 214 FOR A SOCIAL SECURITY APPLICATION.\*
